

## **Doctor of Physical Therapy Program Information** **Class of 2027**

Your financial aid eligibility is based on your FAFSA information and your enrollment. Email notifications are sent to your DeSales account when financial aid packages are available. Financial Aid information can be viewed by logging into *WebAdvisor*. Navigate to *Financial Aid* and select the *Financial Aid Checklist*.

**First-time borrowers** planning to utilize the William D. Ford Federal Direct Loan program at DeSales must complete the Master Promissory Note (MPN) and Entrance Counseling at <https://studentaid.gov/>. Please note that this process must only be completed once while you are enrolled at DeSales University.

Under the Unsubsidized Federal Direct Loan program, a student may choose to make quarterly interest payments or keep the loan fully deferred. Repayment is required six months after graduation or when the student's enrollment drops to less than half-time.

**Additional Loan Options** (*Completed after May 1, 2024*) Students are required to maximize their Unsubsidized Loan Eligibility prior to seeking the additional loan options below:

**Federal Graduate Plus Loan** - Information on this loan program can be found here:  
<https://studentaid.gov/understand-aid/types/loans/plus>. This loan may be deferred for six months after graduation or if the student enrolls less than half-time.

**Private Education Loans** – Students may borrow through private lenders to support their education. These loans may require a cosigner. Private loan rates and terms vary based on the student/cosigner's credit information, choice of a variable or fixed rate loan, and repayment options. If you use a portion of your financial aid for living expenses each semester, you may be eligible to receive a refund of any credit on your account after the drop/add period closes. There will be **NO** refunds issued unless there is a credit balance on your account. If you have received a refund based on your enrollment and you change your enrollment status, you may be required to repay all or a portion of the refund.
